**Introduction.** Accepting these conditions You may use the services related to credit cards that WuBook puts at your disposal. In particular, accepting the relative and current contract, you will have the ability to set up for Your Proprieties, the modality of booking on line in real time. Your customers can use their credit card as a guarantee to confirm the on-line reservation and, the page released from the system will be in effect a document sufficient to use the services chosen. The credit card, by contrast, provides an element of security for the good behavior of the customers. No credit card will be required if the model on-line booking is deferred, that means that your confirmation is required for each reservation request.

**Description of service:**

To activate the management of credit cards and the relative service, you are required to provide an additional password. This password will be used to create a key to encrypt the credit card at the time of reservation using an asymmetric algorithm with key public and private, with safety standards similar at the bank. So, while to encrypt the credit cards Your intervention is not required, for see them you must necessarily have the password provided at the time of the service activation for the credit cards. WuBook does not keep your password, so only you will be able to read the credit card of your customers. It follows that, in case you lose the password, the data relating to credit cards are not restorable. In this case, it will be necessary and possible the creation of a new password, although the old data related to credit cards are not recoverable any more.

**Please note that during the booking online any payment will be made, the credit cards service is only as an instrument of pure guarantee of the booking on line.**

The credit card is controlled in its anatomy by the Luhn's algorithm. The all and only credit cards accepted are the one for which it is possible to do the above checks algorithmic: Visa, MasterCard, American Express, Discover, Enroute, JCB, Diners and related subfamilies. Also note that the success of a control does not mean the authenticity of the credit card used, although this discrepancy is absolutely unlikely. As a result of the above mentioned, you agree that:

- WuBook does not guarantee the authenticity of the credit cards, although the algorithms employed for the anatomical controls are technologically advanced in relation to the current state of the art.
- WuBook has no way to access the credit card of your customers.
- WuBook has no way to provide you the credit card reservations.
- Any circulation of credit cards of your clients, even if the origin of the distribution are attributable to the WuBook use, are entirely to your responsibility, being the only one who knows the password to decrypt.
- WuBook does not offers any service for the collection of the payments or penalties that you establish with your customers. The activation of credit cards and their management are all under your responsibility.
- WuBook is completely relieved from any disputes between you and your customers in relation to the credit cards.

**Competent Court:** Any dispute relating to the interpretation and/or execution of this contract shall be settled exclusively by the Court of Pesaro (PU).

**Conclusion:** This contract, that meets the "General Terms and Conditions and Data" in its latest and updated version (which will adjust automatically all other WuBook srl services purchased by you in advance) is fully referred and transcribed in its entirety, without exception, including therefore also the provision under Articles. 1341 and 1342 CC, must also be understood and interpreted adjusted in accordance with Italian law. For the aspects not specifically covered by this contract, will be applied the provisions of the Civil Code.
